Added Protection on Rental Equipment

By purchasing the Rental Protection Plan, you will not be held responsible for the full replacement value of damaged or stolen equipment. If something does go wrong, you will be responsible for 5% of the damage costs or \$450.00, whichever is less.

What does RPP cover?	
Damage to Cold Air Rentals Equipment	Accidental damage, as long as the damage does not result from intentional abuse of the equipment.
Theft of Cold Air Rentals Equipment	Theft of equipment.

What is not covered by RPP?	
Damage to Equipment Resulting from Abuse	Damage to equipment resulting from intentional abuse.

**Customer is responsible for the care and safekeeping of the rental equipment from the time of delivery until the retrieval by the Company. The customer agrees that it will use its best efforts to protect the equipment from loss, theft or damage at all times during the rental period, and until the equipment is retrieved and in the Company's possession.
